

PROTECTION AND PROCESSING OF MAYA FOUNDATION MEMBERS' PERSONAL DATA CLARIFICATION TEXT

Pursuant to the Law on Protection of Personal Data numbered 6698 (“**Law**”), Maya Foundation (“**Foundation**”) as data responsible shall be able to process your personal data under the framework described below.

a) Purpose for which personal data can be used

Under the framework of personal data processing conditions set under the 5th and 6th articles of the Law, Foundation shall be able to use your personal data collected for the purposes of (“**Purposes**”);

- To ensure legal, technical and commercial-business security of the Foundation and the related persons in business relationship with the Foundation,
- In order to perform the activities carried out by the Foundation, our relevant work units conduct necessary studies and execute relevant work processes.

b) To whom and for what purpose the processed personal data can be transferred

Foundation shall be able to transfer your collected personal data in order to fulfill the Goals under the conditions and purposes of personal data processing specified under the 8th and 9th articles of the Law on Protection of Personal Data to our business partners, our suppliers, public institutions and private persons or establishments and third persons legally authorized .

c) Method of and legal reason for collecting personal data

Your personal data are collected by the Foundation based on your open will and the conditions of personal data processing specified under the 5th and 6th articles of the Law with the method of [_____] on physical/electronic medium for the purpose of operating the processes regarding your membership to the Foundation.

d) Rights of the personal data owner, as listed in the 11th article of the Law

We notify that you have the following rights as personal data owner, pursuant to the 11th article of the Law:

- To learn if your personal data are processed or not,
- If your data are processed, to request information on such processing,
- To learn the purpose behind processing of your personal data and whether they are used in line with such purpose,
- To know the third persons to whom your personal data are transferred in Turkey or abroad,
- To ask for correction in case your personal data are processed incompletely or wrongly and request that the procedure done under this scope are notified to the third persons your personal data are transferred to,
- To ask personal data are erased or destroyed despite they are processed pursuant to the Law and provisions of other related laws, in case the reasons behind such processing disappear and to request that the procedure done under this scope are notified to the third persons your personal data are transferred to,

- To make objection in case a situation to your detriment occurs as a result of analysis of the processed data exclusively by automatic systems,
- To request removal of any loss you incur due to any unlawful processing of your personal data.

For your applications regarding your rights listed above, you can contact our Foundation filling Maya Foundation Data Owner Application Form that you can reach via [____]. Your applications shall be concluded free-of-charge within the shortest possible time according to the kind of your demand and within thirty days at the latest; but in case the procedure requires an extra cost, you may be asked a fee according to the tariff determined by the Board of Personal Data Protection.
